PLAYER TOURNAMENT REPRESENTATIVE AGREEMENT AND CODE OF CONDUCT

1. The Board of Hawke's Bay and Poverty Bay Women Incorporated ("the Board") is prepared to offer you a place as a member of the Provincial Representative Team, participating in the Tournament set out in the Schedule below.
2. Final selection for the Team is subject to you (or where you are not yet 18 years of age, your parent or guardian) agreeing to and signing this Player Agreement. For that purpose you agree as set out below:
3. As a representative player in the tournament you or your Parent or Guardian on your behalf, confirm by signing below that they or you agree to and will:
 - Recognise that you are representing your Province which requires that you set high standards of personal behaviour and dress;
 - Where Association equipment and clothing is provided you will use it and return it in a clean and good condition at the conclusion of the Tournament;
 - You will follow and respect the Board's policies associated with your membership of a Provincial Team;
 - You will comply with the directions of the Team Manager or the Board at all times;
 - You will always play in accordance with the Rules of the game of Golf;
 - You will never argue with an Official. If you disagree with a decision you will inform your Team Captain or Team Manager during a break in play or after the competition;
 - You will control your temper. You accept that verbal abuse of Officials and other players or behaviour deliberately distracting or provoking an opponent is not acceptable or permitted behaviour;
 - You will be a good sport and acknowledge good play whether made by your Team or the opposition team;
 - You will treat all players in your sport as you would wish to be treated. You will not bully or take unfair advantage of another competitor;
 - You will co-operate with the Team Manager, the members of your Team, and where necessary with members of the opposing team;
 - You will display modesty in victory and graciousness in defeat;
 - You will respect the rights, dignity and worth of all participants regardless of their gender, ability, cultural background or religion;
 - You will thank the opposition and Officials at the end of the game;
 - You will remain with the Team at after match functions;

- You agree to undergo random drug or alcohol testing at any time after signing this Agreement, and until the expiration of one month after the completion of Tournament specified in the Schedule, as directed by the Team Manager or the Board;
- You agree to go to such place or places immediately as directed by the Team Manager or the Board, and to then provide urine or other required samples for analysis as required by the Board, the Team Manager, or the testing facility to determine whether you have taken or used prohibited drugs, stimulants or substances;
- You agree to accept immediate suspension or dismissal from any representative team by the Team manager or the Board in the event that any sample analyzed confirms that you have taken or used prohibited drugs, stimulants or substances;
- You will accept any other playing sanction that the Board may determine appropriate to protect the reputation of Hawke’s Bay Representative Golf as a “Drug Free Sport”;
- You will disclose to the Board immediately any prescription drugs or medicines that you may be required to take for your personal health. You acknowledge that if you fail to disclose such medicines or drugs prior to any drug testing the Team Manager or the Board may require, then the Board may determine to impose Team or player sanctions should a positive drug testing result eventuate.
- You agree that you will not:
 - Leave the Team at any time during or after match functions (without the consent of the team manager)
 - Act independently of the Team at social occasions without the express permission of the Team Manager;
 - Go through any other person’s property or act in a manner which invades or threatens their personal space;
 - Arrive at the venue or play sport while intoxicated or after you have taken or used prohibited drugs stimulants or substances;
 - Bring the Provincial Association into disrepute in any manner;
 - Make any public statement about drug testing required under this Agreement or the results of drug testing in relation to any other player or yourself without the prior permission of the Board.
